

Situated in the City of Elyria, County of Lorain and State of Ohio and being a part of Original Lot No. 31, West of the Black River of said township; also being part of Sublot Nos. 493, 494, 495 and 496 and all of Sublot Nos. 497 to 504 inclusive, Sublot Nos. 509 to 520 inclusive, Sublot Nos. 523 to 536 inclusive and Sublot Nos. 538 to 549 inclusive and part of 49th Street (now vacated) in the Leona Heights Allotment as appears in Plat Volume 6, Pages 35 and 36 of the Lorain County Record of Plats; being further bounded and described as follows:
