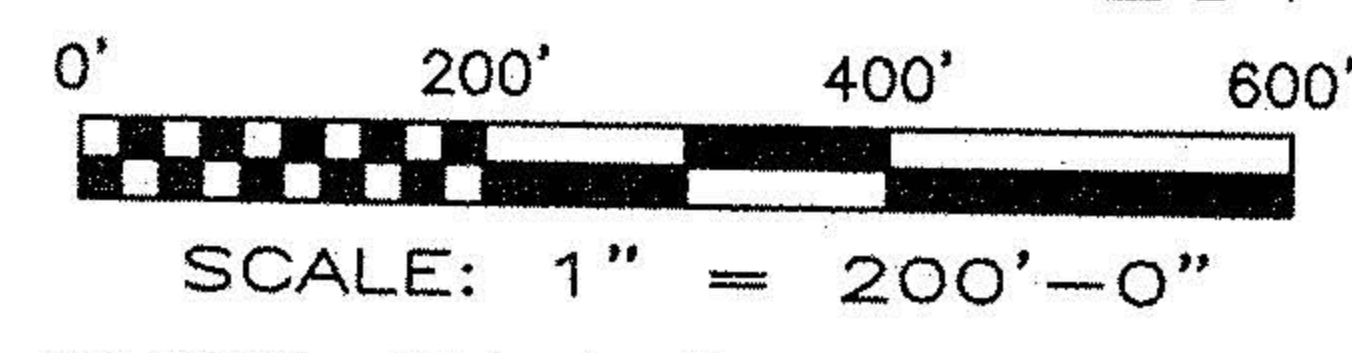


BAGLEY ROAD 50' (FORMERLY BEREA ROAD)

MAP OF SURVEY FOR RIDGEFIELD HOMES


