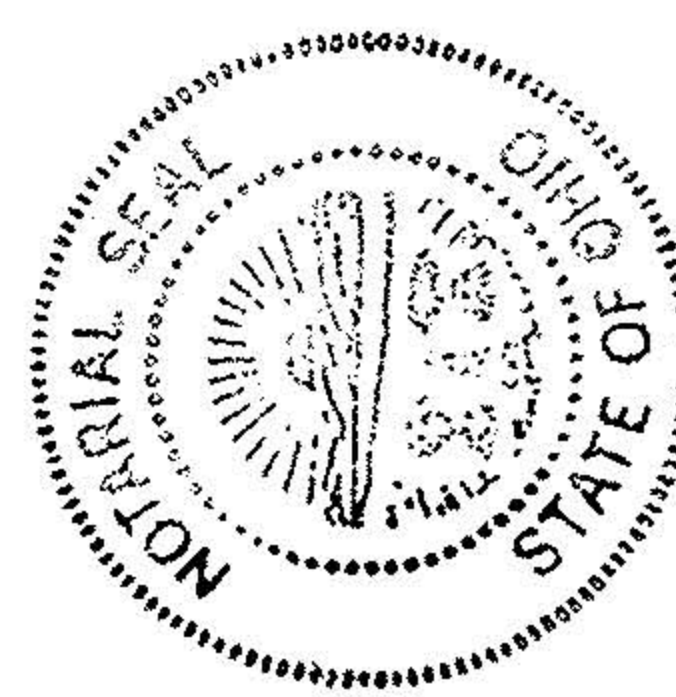

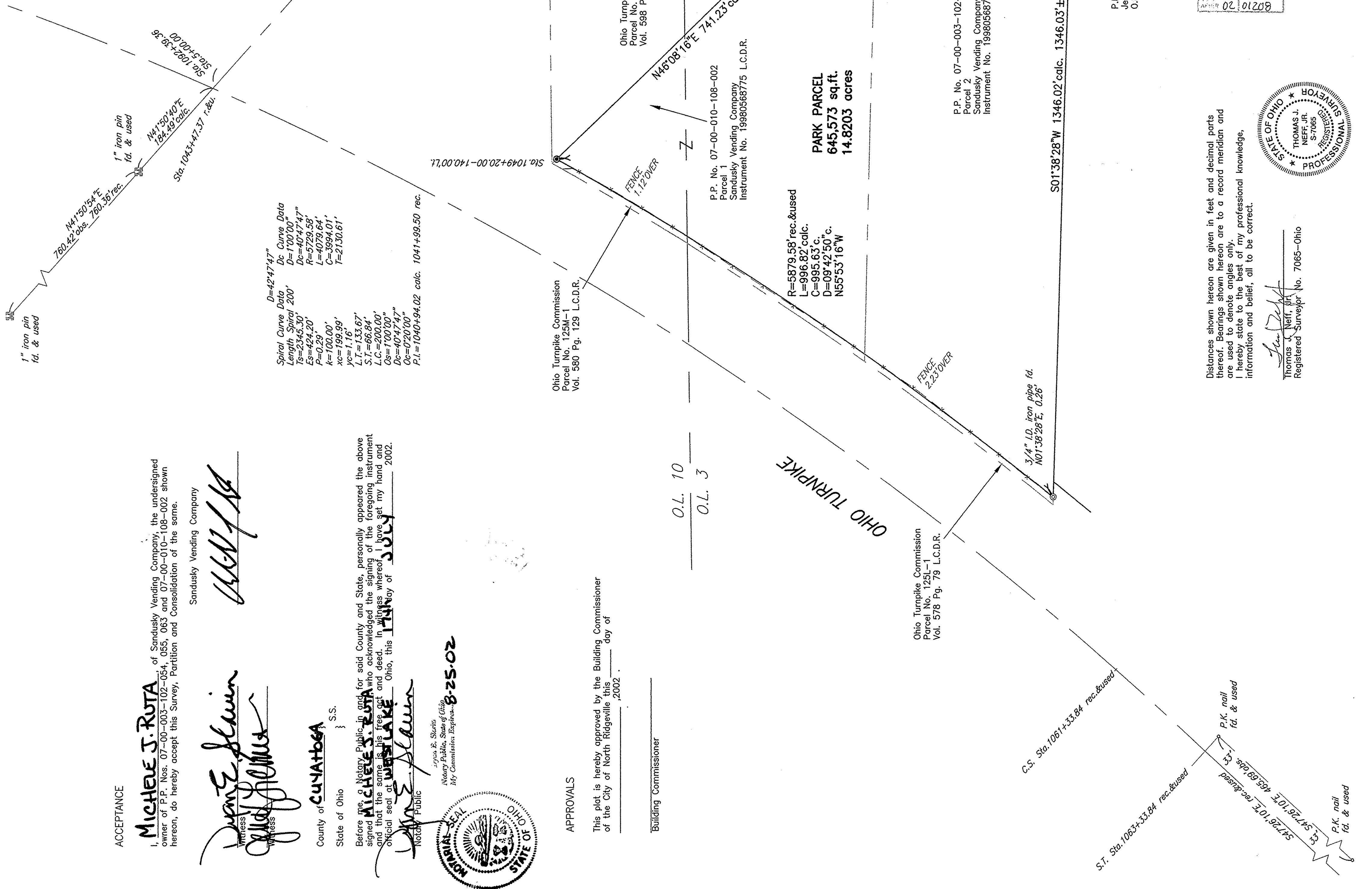

BUTTERNUT RIDGE ROAD (S.R. 10) VARIABLE WIDTH

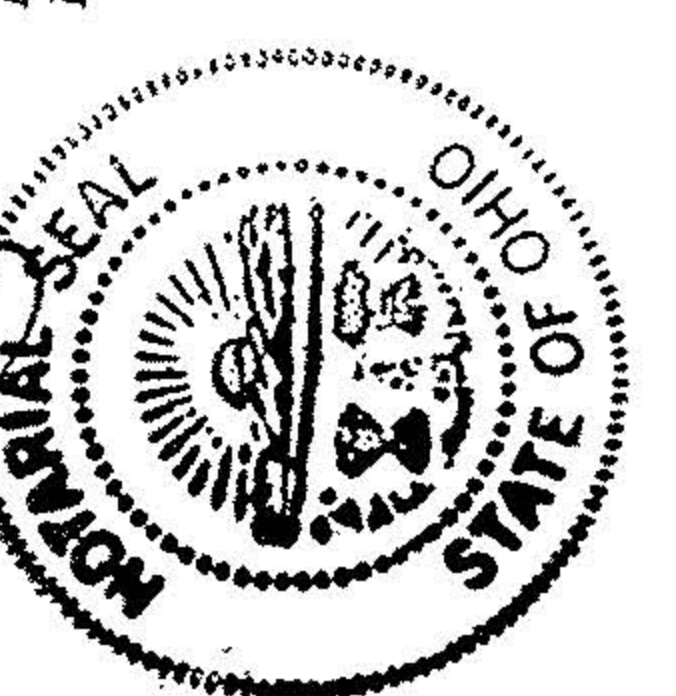

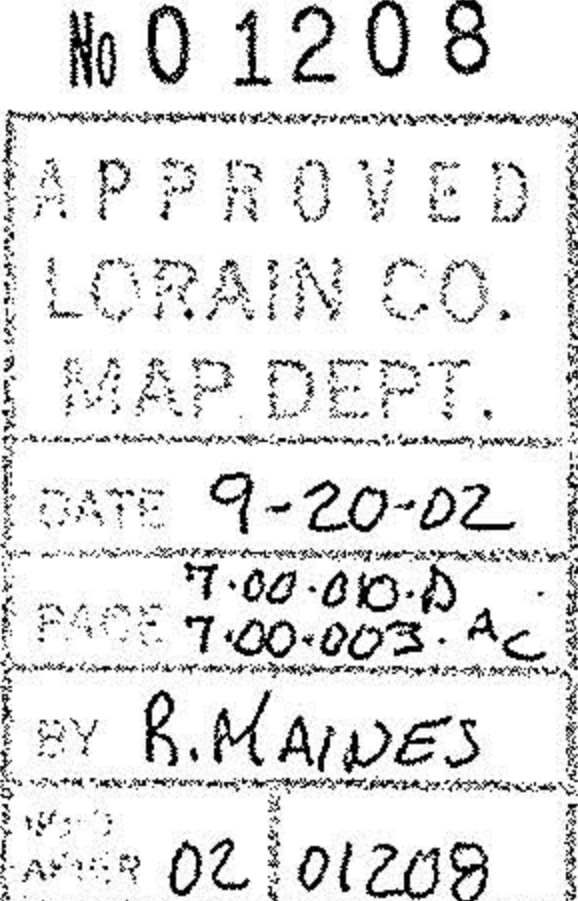

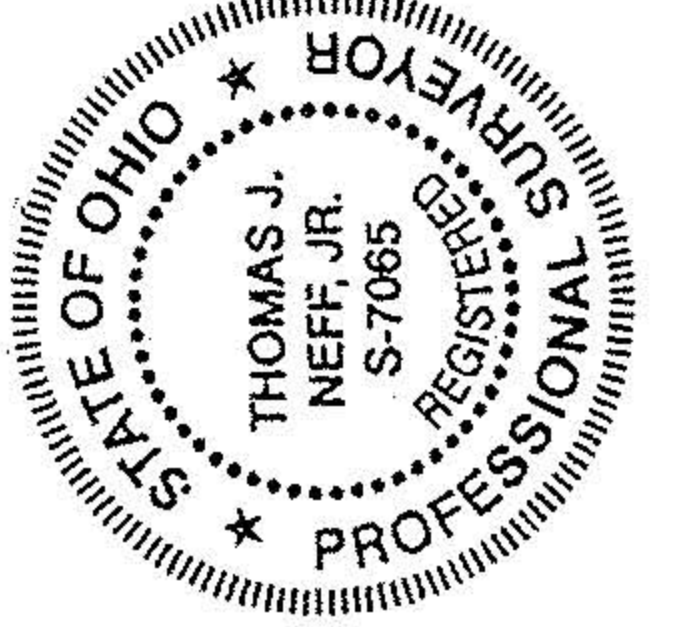
