



DESCRIPTION 1.151 ACRE PARCEL :

THENCE NORTH 8°00' EAST ALONG SAID CENTERLINE, A DISTANCE OF 125.00 FEET TO THE SOUTHWEST CORNER OF LANDS CONVEYED TO CLAIRE F. AND KATHERINE M. THENCE SOUTH 1°38' EAST, A DISTANCE OF 123.24 FEET TO A POINT. THENCE SOUTH 88°22' WEST IN A LINE PARALLEL TO GAUMAN'S SOUTHERLY LINE, A DISTANCE OF 417.42 FEET TO THE PLACE OF BEGINNING, EMBRACING 1.151 ACRES OF LAND, BUT BEING SUBJECT TO ALL LEGAL HIGHWAYS.

GAUMAN BY DEED RECORDED IN VOLUME 1072, PAGE 225 OF LORAIN COUNTY DEED RECORDS, SAID POINT BEING NORTH 88°22' EAST A DISTANCE OF 396.50 FEET FROM THE CENTERLINE OF QUARRY ROAD. THENCE NORTH 88°22' EAST ALONG GAUMAN'S SOUTHERLY LINE, A DISTANCE OF 300.00 FEET TO AN IRON PIN SET. THENCE SOUTH 1°38' EAST, A DISTANCE OF 123.24 FEET TO AN IRON PIN SET. THENCE SOUTH 88°22' WEST IN A LINE PARALLEL TO GAUMAN'S SOUTHERLY LINE, A DISTANCE OF 300.00 FEET TO A POINT. THENCE NORTH 1°38' WEST, A DISTANCE OF 123.24 FEET TO THE PLACE OF BEGINNING, EMBRACING 0.849 ACRE OF LAND, BUT BEING SUBJECT TO ALL LEGAL HIGHWAYS.
