

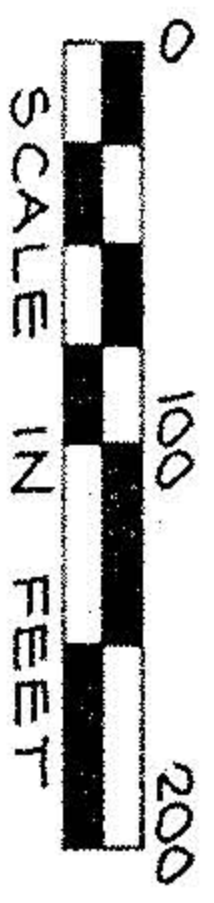
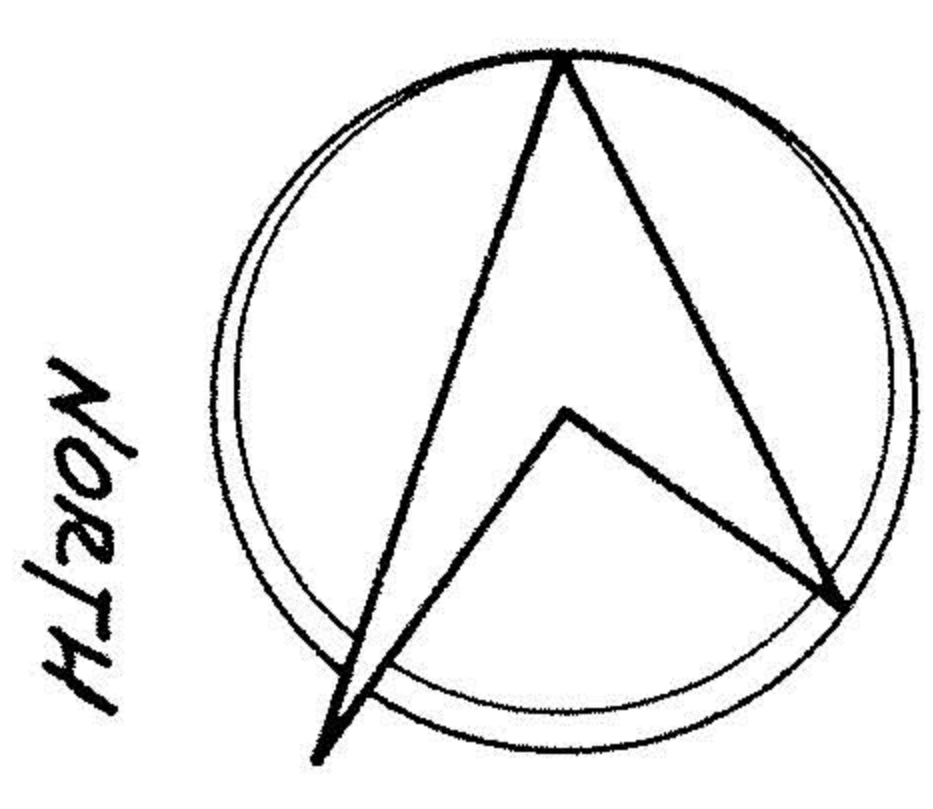
MAP OF SURVEY & PARTITION

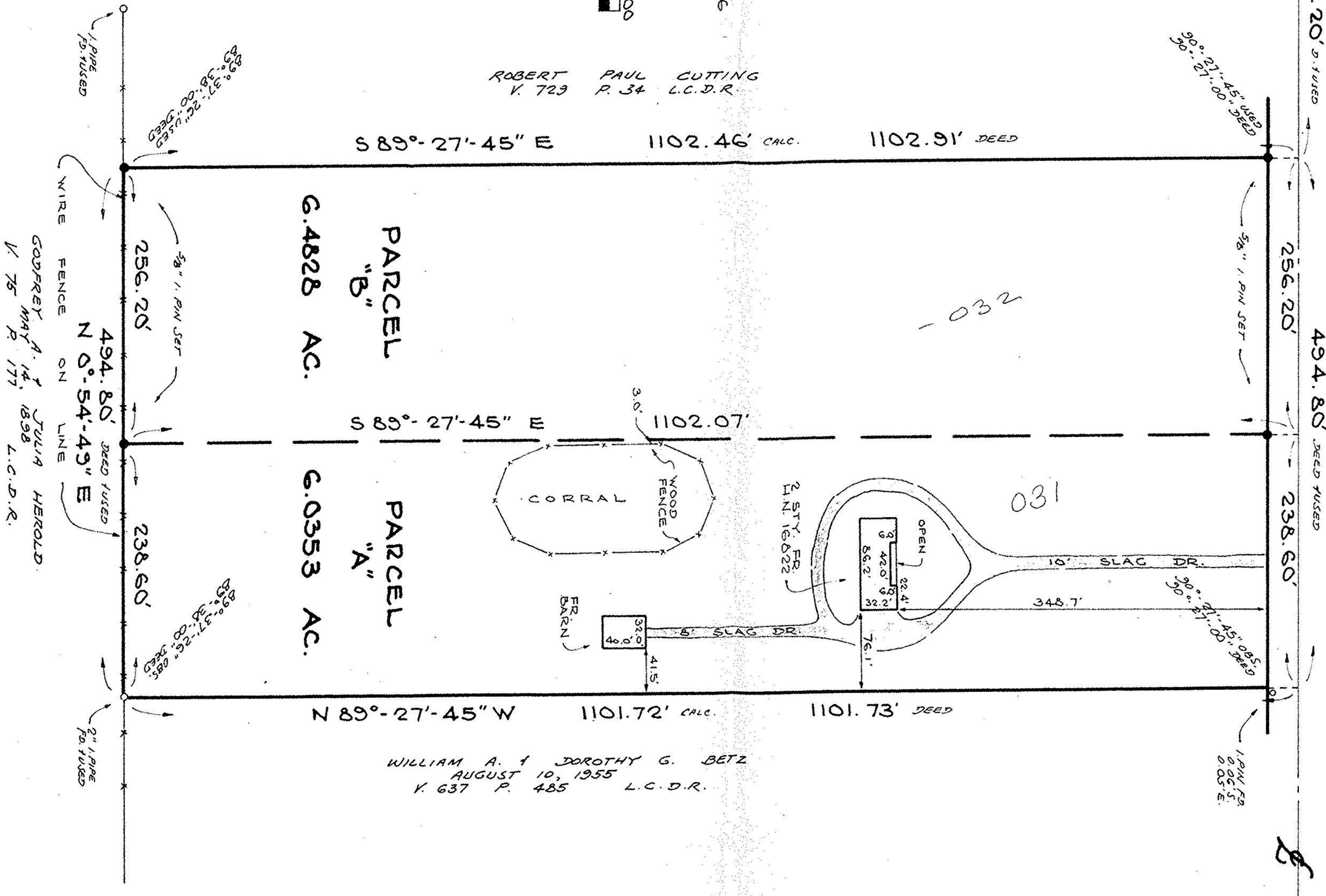

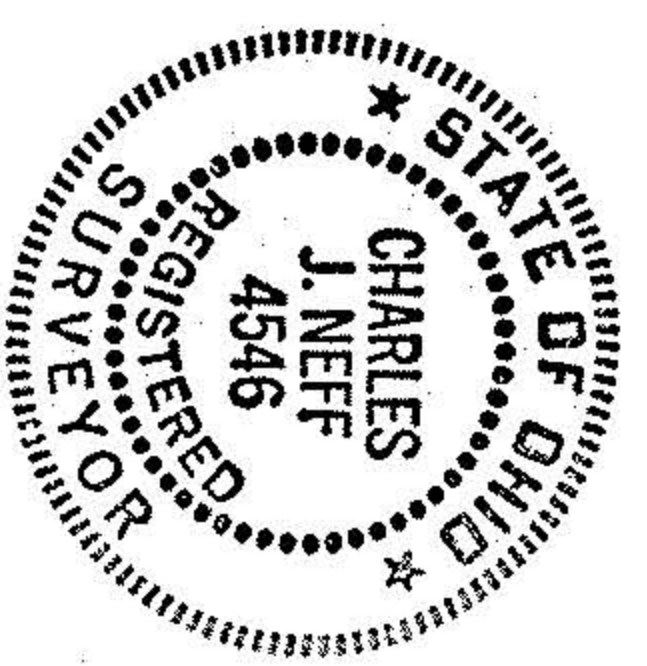
