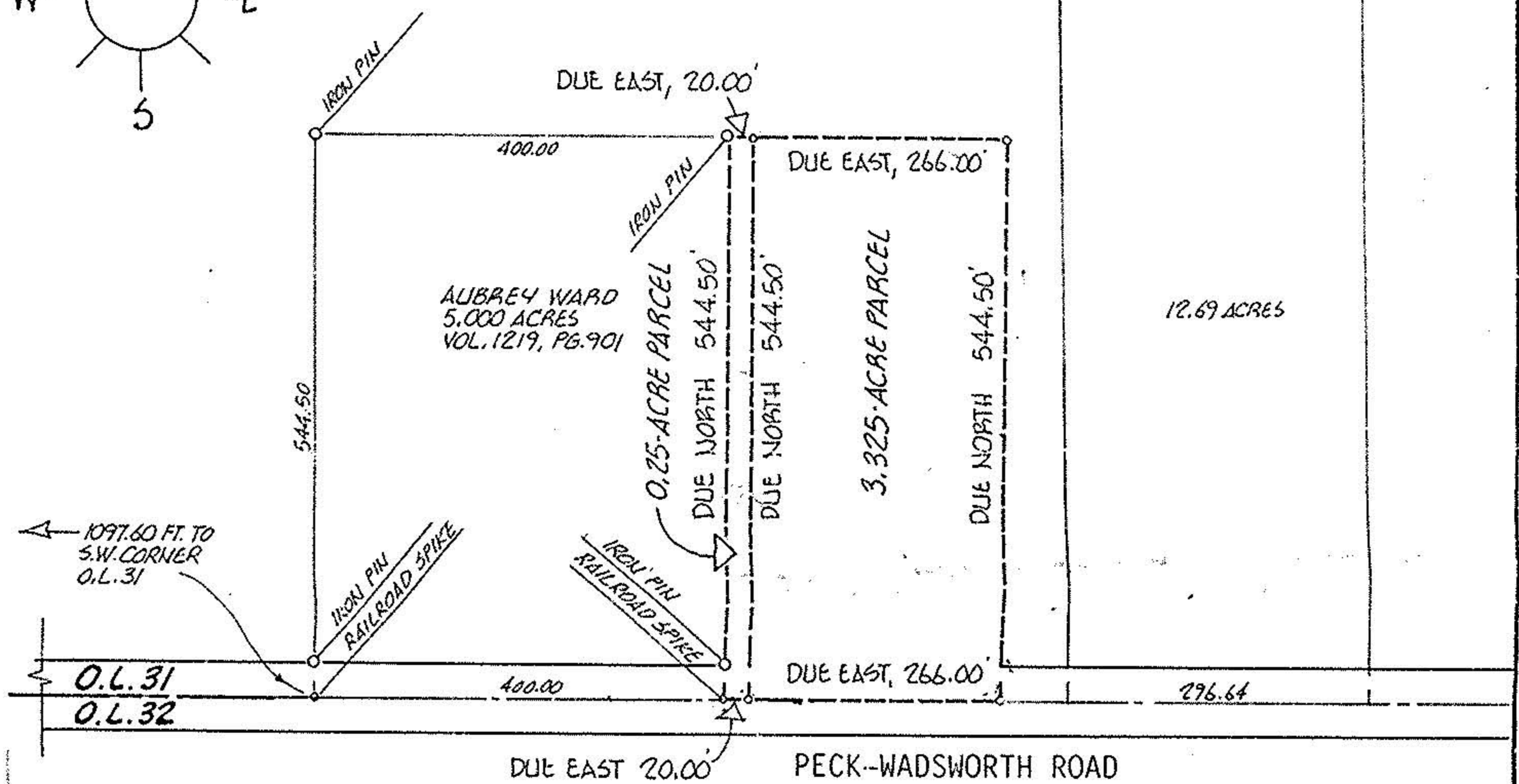
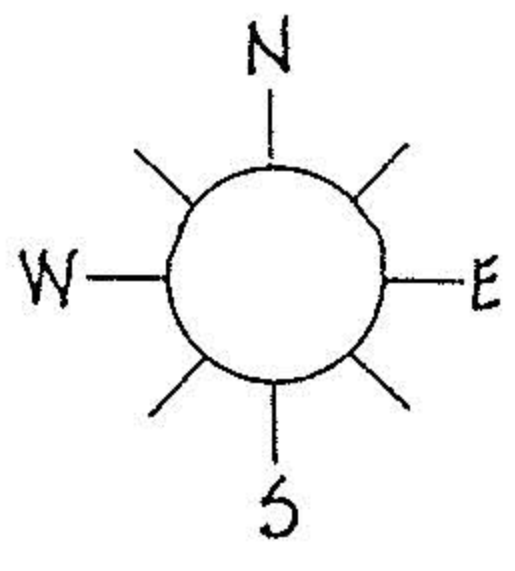

DESCRIPTION, 0.25 acre PARCEL;

THENCE Due East along said centerline, a distance of 20.00 feet to a point. THENCE Due North a distance of 544.50 feet to a point. Thence Due West, a distance of 20.00 feet to an iron pin. THENCE Due South, a distance of 544.50 feet to the place of beginning, embracing 0.25 acre of land, but being subject to all legal highways.

THENCE Due East along said centerline, a distance of 266.00 feet to a point. THENCE Due North, a distance of 544.50 feet to a point. THENCE Due West, a distance of 266.00 feet to a point. THENCE Due South, a distance of 544.50 feet to the place of beginning, embracing 3.325 acres of land, but being subject to all legal highways.
