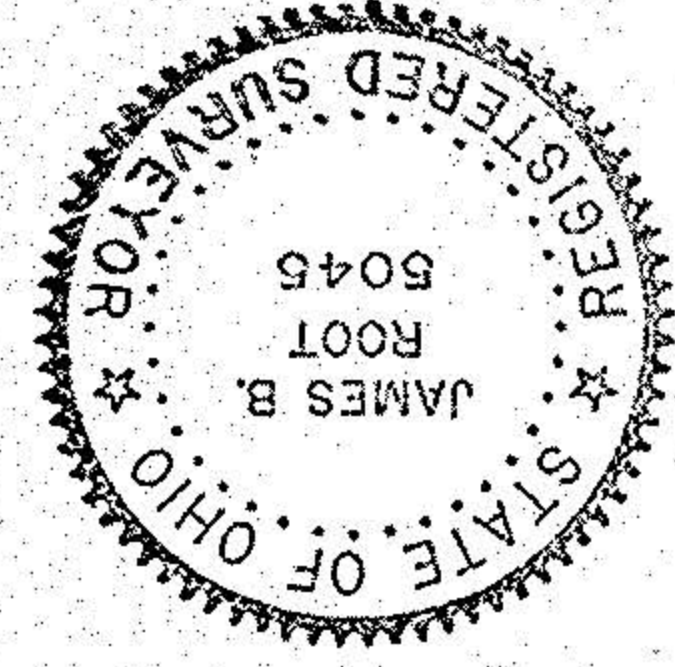


# LOT SPLIT MAP FOR RICHARD E. & DONNA LANGE

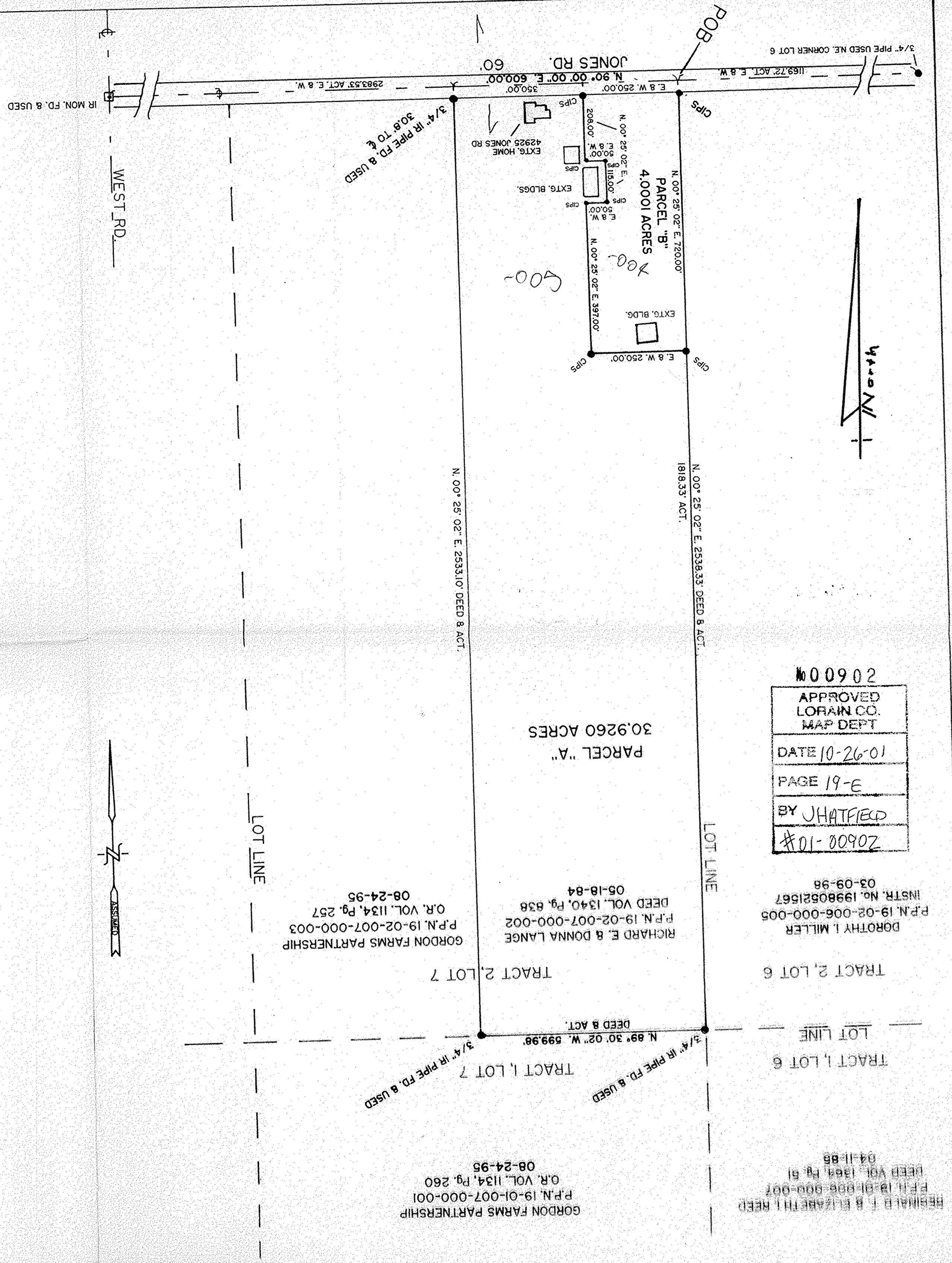
