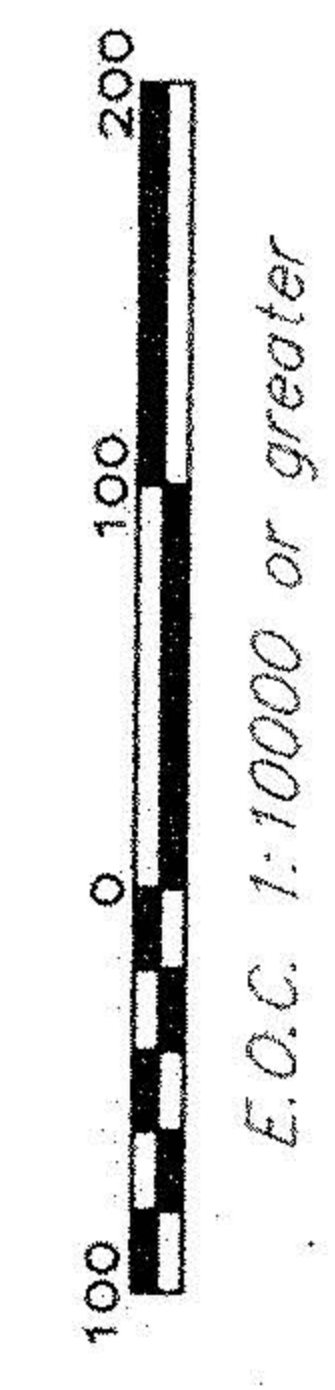

Lorain County, Ohio


