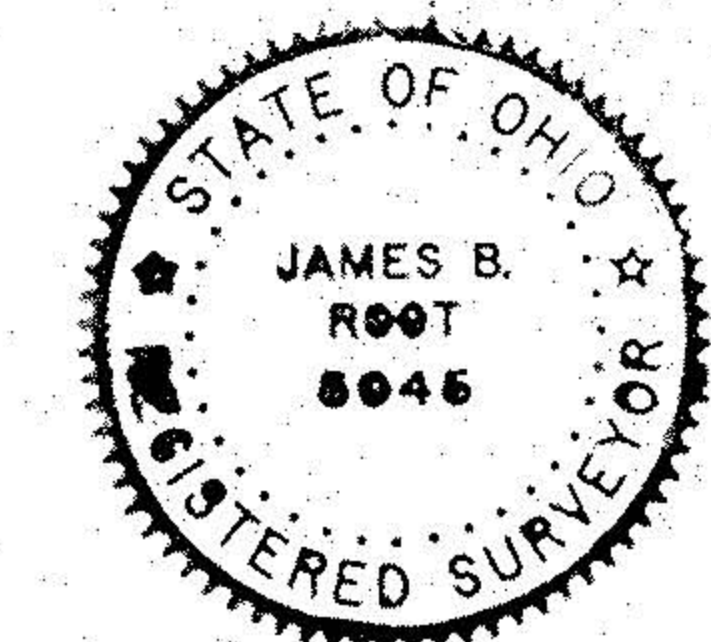


PROPOSED LOT SPLIT MAP FOR FRANK AND MARIA MOWINSKI
