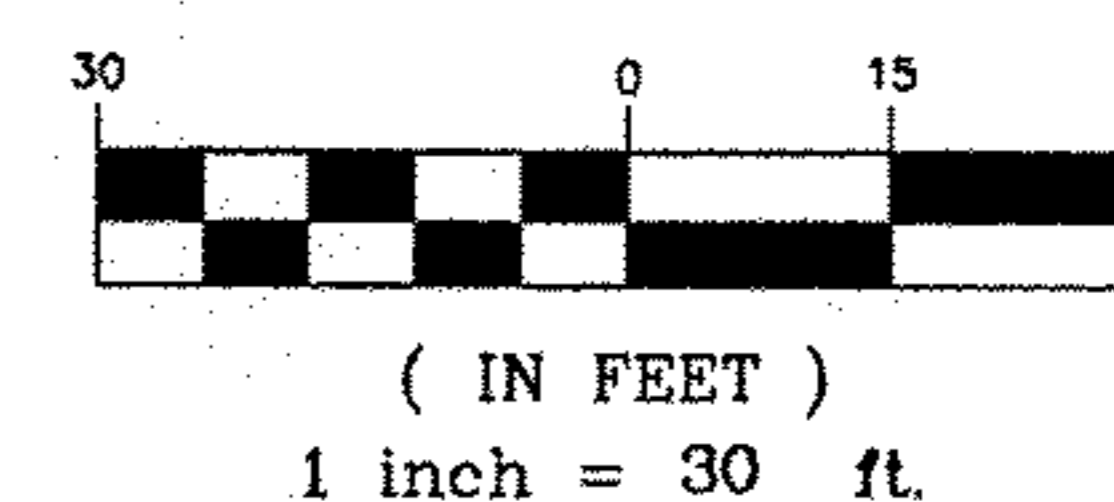

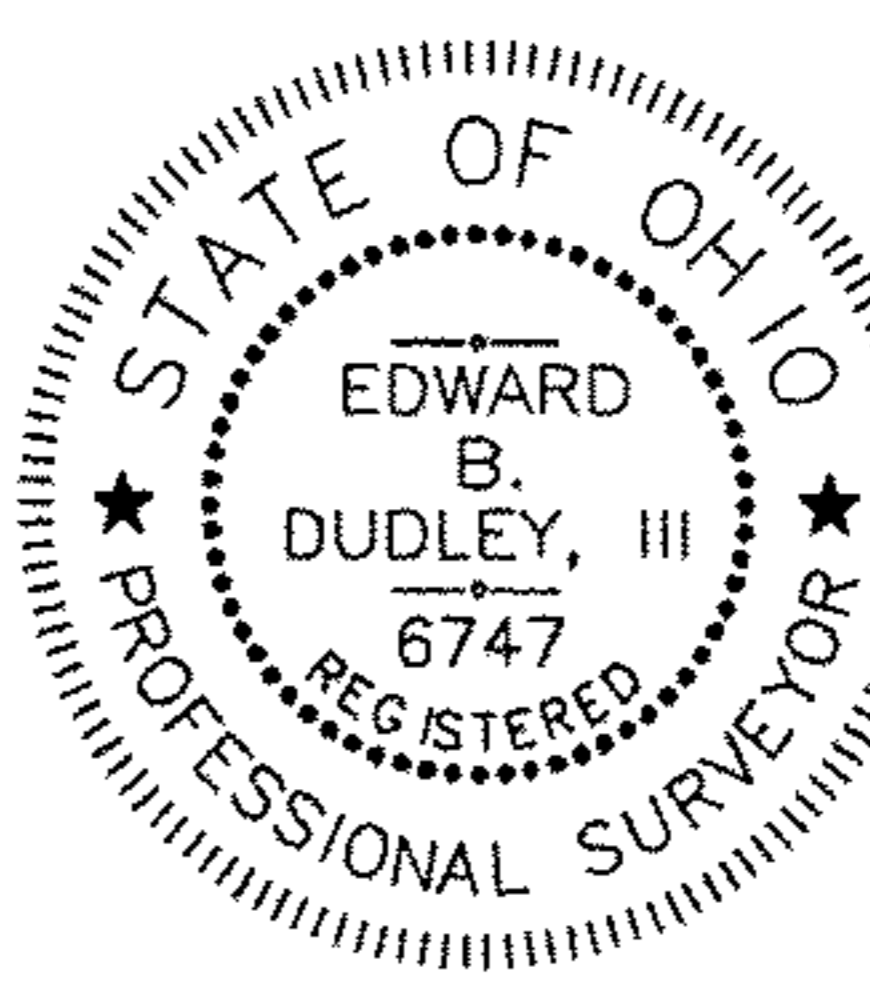


SURVEYOR CERTIFICATION
