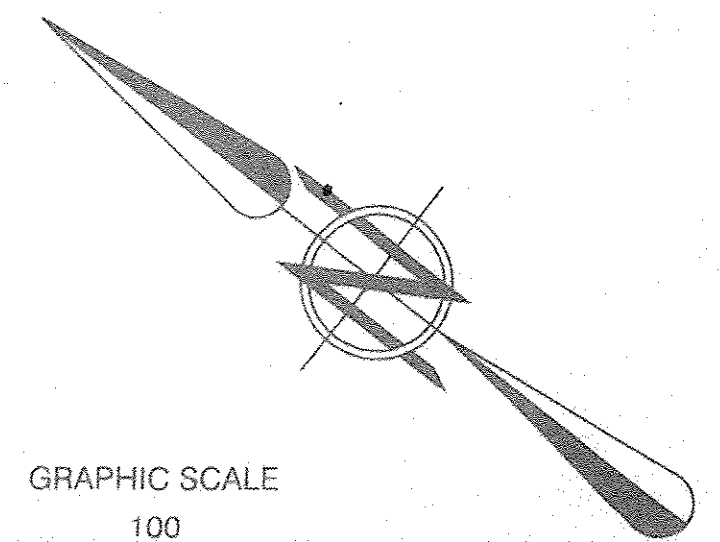


BOUNDARY SURVEY

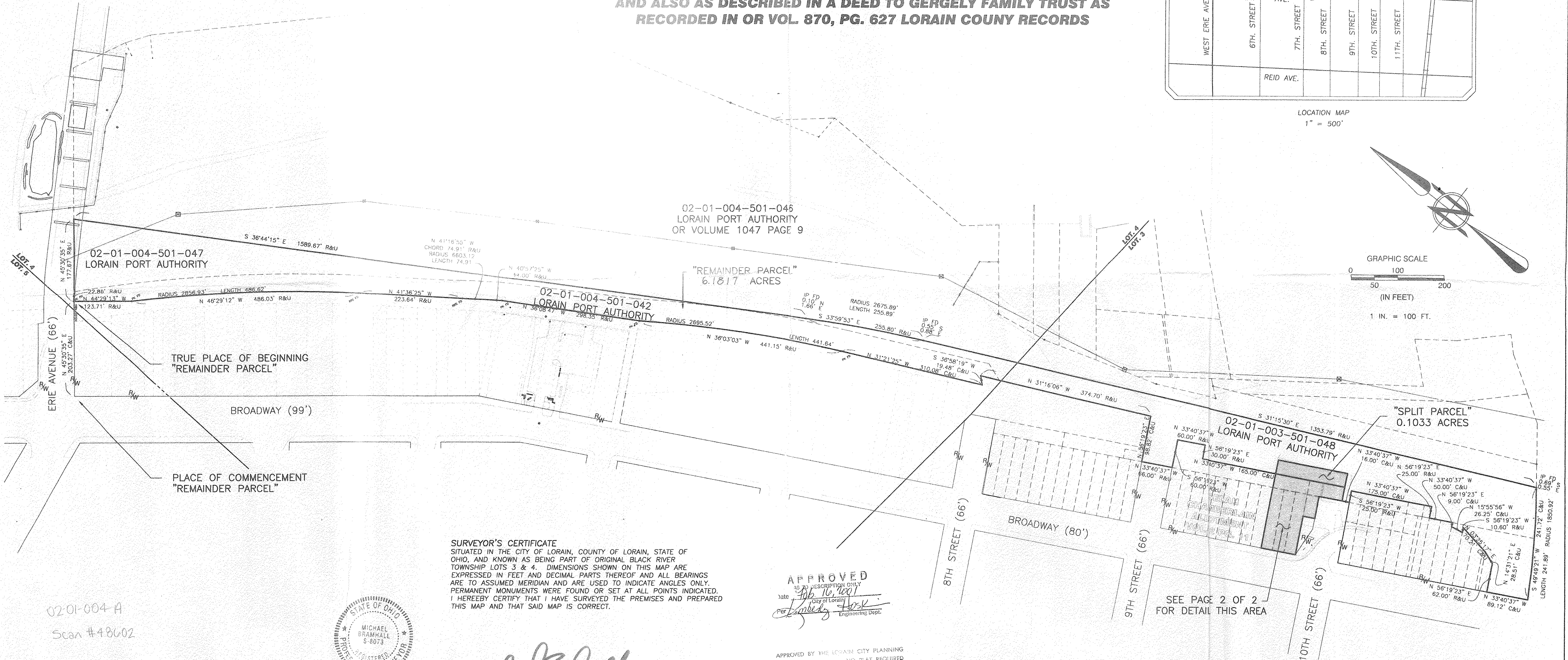

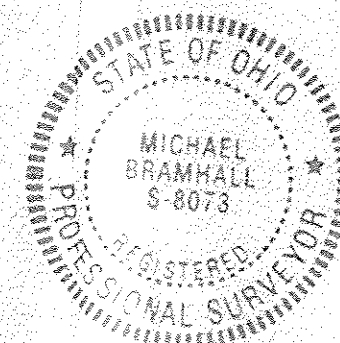
LOCATION MAP
