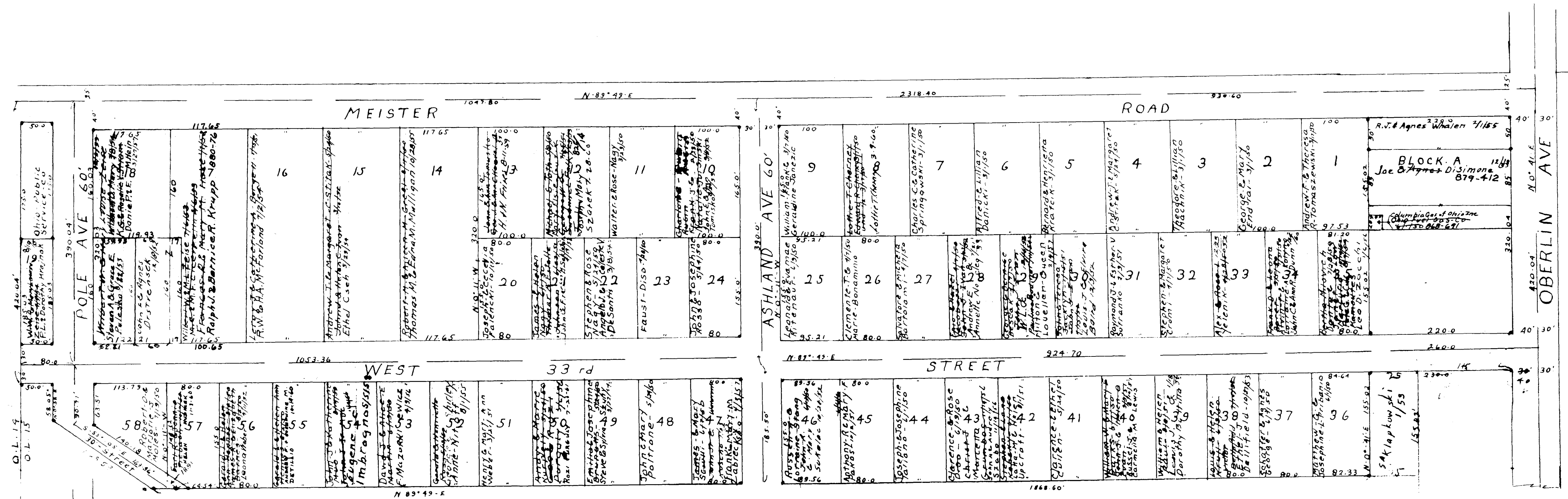

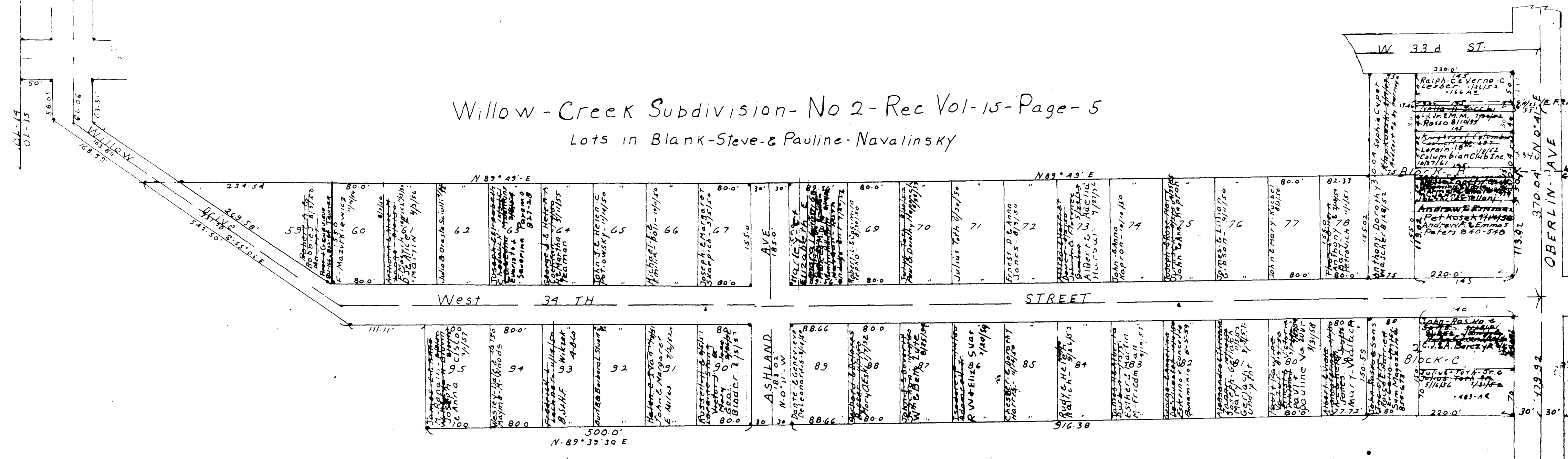

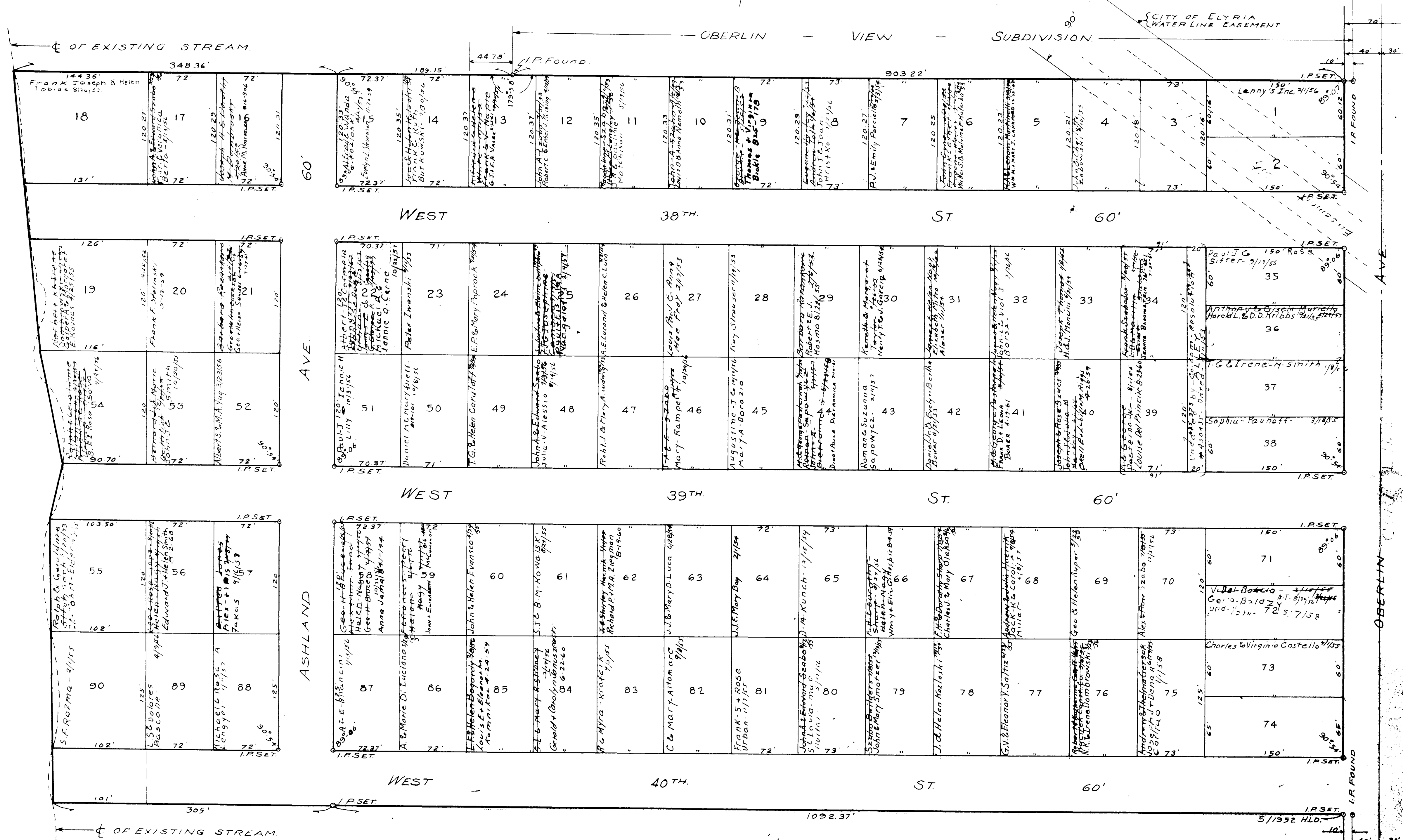
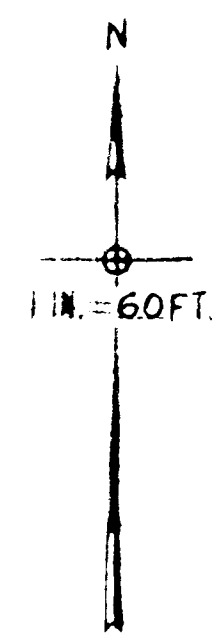
TRACT 2 ORIGINAL LOT 15
