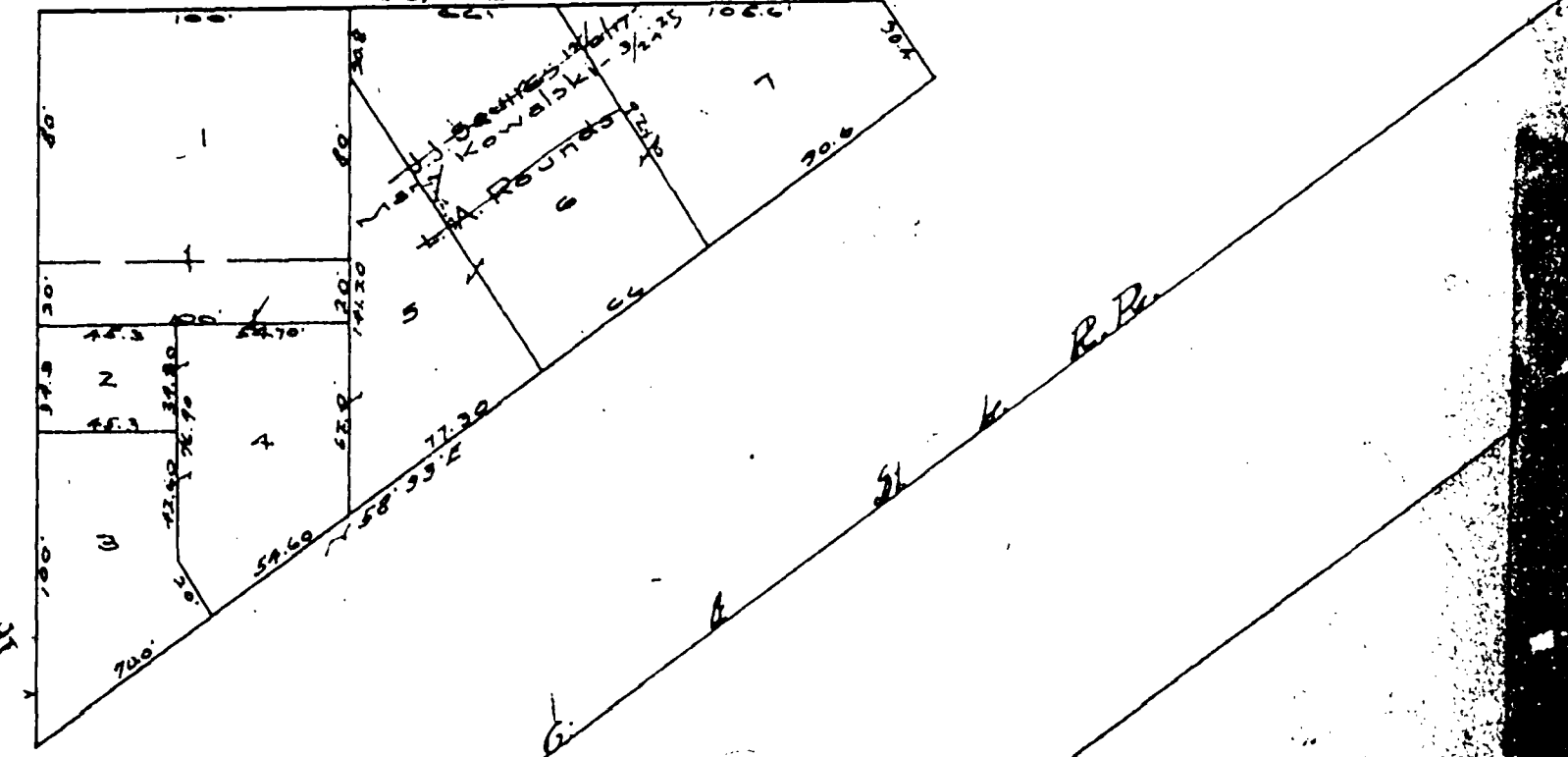
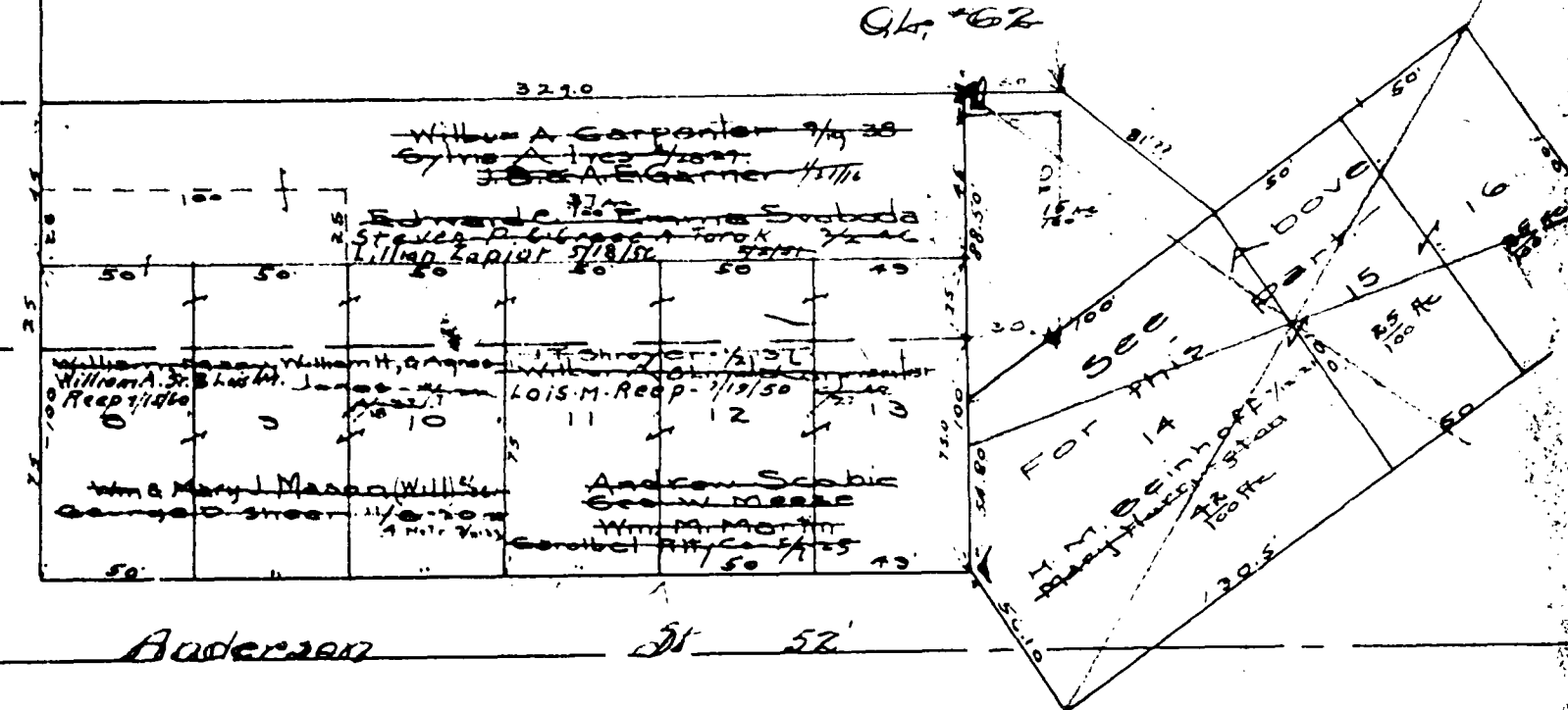
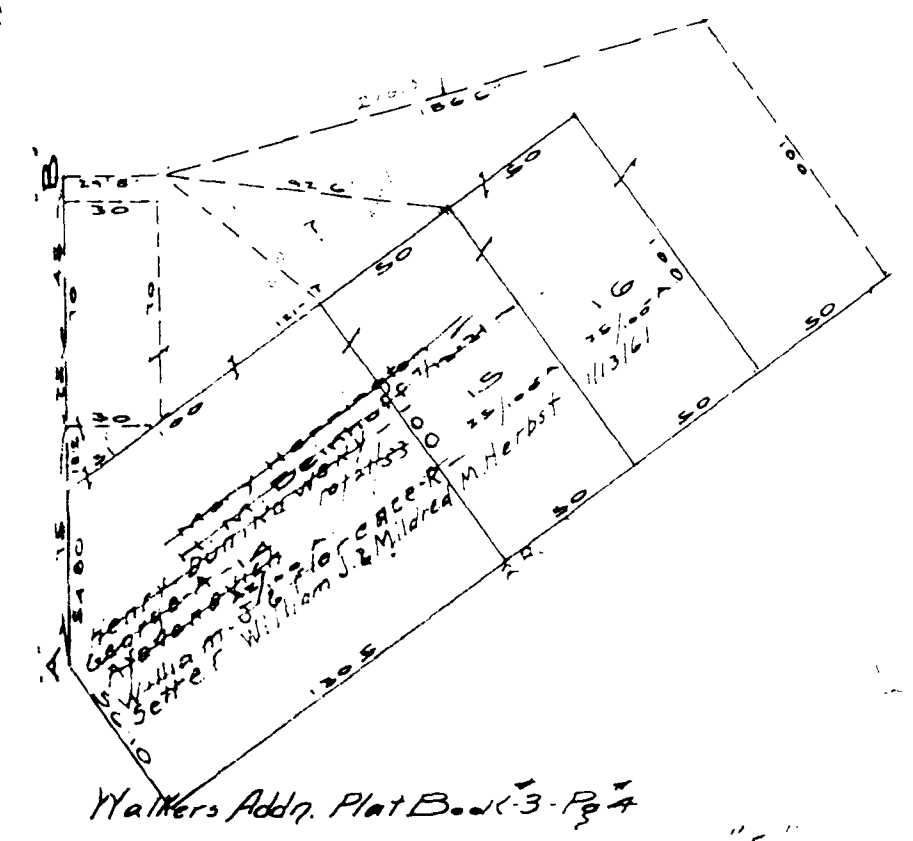


Columbia Twp

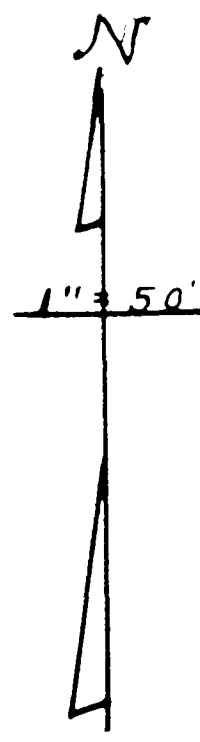
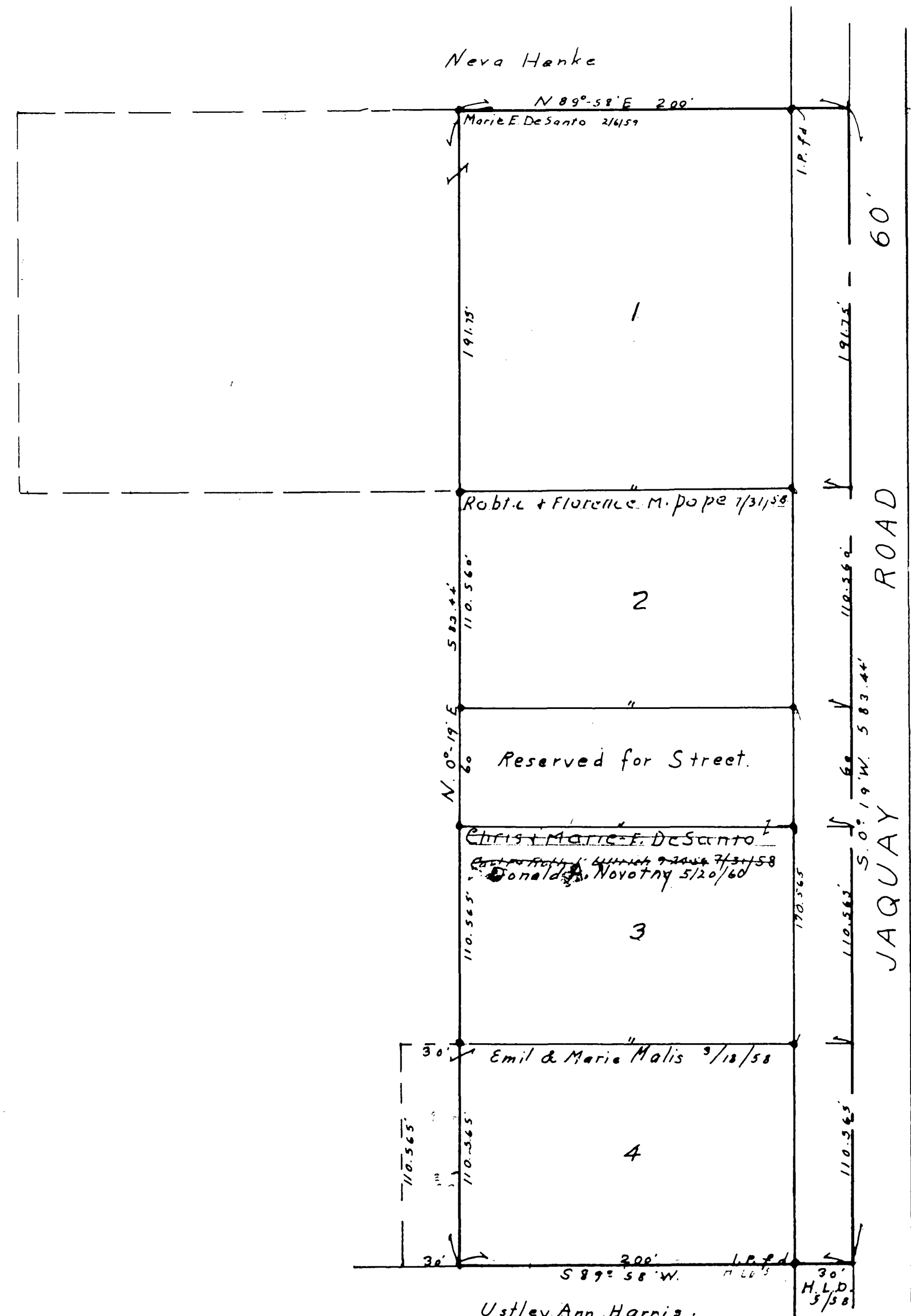
